## INFORMATION ON THE EXERCISE OF THE RIGHT OF WITHDRAWAL IN THE CASE OF A DISTANCE CONTRACT

1. Within 14 (fourteen) days, you shall have the right to withdraw from the distance contract, without giving any reason, thus refusing from all numismatic coins purchased under the purchase order.
2. The withdrawal period shall expire after 14 (fourteen) days, starting from the date when you or the person (other than carrier) indicated by you have/has taken possession of the numismatic coins (depending on the moment, whichever sets in earlier).
3. In order to exercise the right of withdrawal, you shall have to inform Latvijas Banka of your decision to withdraw from the concluded distance contract by an unequivocal statement containing the information necessary for the identification of the buyer and the concluded distance contract.
4. A model withdrawal form or a self-prepared notice of withdrawal shall have to be submitted to Latvijas Banka in one of the following ways:
  - 4.1 by e-mail: [monetas@bank.lv](mailto:monetas@bank.lv);
  - 4.2 by post (address: K. Valdemāra iela 2A, Rīga, LV-1050);
  - 4.3 by submitting the form to the Cashier's Offices of Latvijas Banka at K. Valdemāra iela 1B in Rīga or Teātra iela 3 in Liepāja.
5. In the event of the exercise of the right of withdrawal, you shall have to return all numismatic coins acquired under the purchase order to Latvijas Banka no later than within 14 (fourteen) days from the date when you notify Latvijas Banka about your decision to withdraw from the distance contract. The numismatic coins may be returned by sending them to Latvijas Banka (K. Valdemāra iela 2A, Rīga, LV-1050 or Teātra iela 3, Liepāja, LV-3401) or by returning them to the Cashier's Office of Latvijas Banka at K. Valdemāra iela 1B in Rīga or Teātra iela 3 in Liepāja.
6. The withdrawal period shall be deemed to have been observed if all the numismatic coins acquired under the purchase order are returned prior to expiry of the period of 14 (fourteen) days referred to in Paragraph 5. You have refused from the exercise of the right of withdrawal by failing to return all the numismatic coins acquired under the purchase order to Latvijas Banka by the established date.
7. You shall have to cover all costs related to the returning of the numismatic coins.
8. The numismatic coins shall have to be returned along with their integral parts (certificates and packagings) according to quality in which they were delivered to you. You shall be responsible for the decrease in the value of the numismatic coins.
9. If you exercise the right of withdrawal, you shall be repaid all payments received from you (the price of the numismatic coins and their packaging and delivery expenses (if any)). If you have expressed the wish to use the type of delivery that is not the cheapest standard type of delivery offered by Latvijas Banka, Latvijas Banka shall not repay you additional costs of delivery.

10. The repayment of the amount of money shall be made within 14 (fourteen) days from the date when Latvijas Banka has received your withdrawal form or notice of withdrawal. Latvijas Banka shall have the right to suspend the repayment of the price of the numismatic coins and the packaging and delivery expenses until the moment when Latvijas Banka has received all numismatic coins acquired under the purchase order. The repayment of money shall be made by using the same payment instrument you have used when making the payment for the purchase.
